Context Statement

Hamilton Secondary College caters for students from 7-12. At the time of this report, the enrolment in 2023 is 551. Hamilton Secondary College is classified as Category 3 on the Department for Education Index of Educational Disadvantage.

At the time of this report, the school population includes 10% Aboriginal students, 14% students with disabilities, 13% students with English as an additional language or dialect (EALD) funded background, 2% children/young people in care. The College is a STEM focus school with a vision that is focused on Space and Astronomy which is an area of growth. In 2022, the College introduced a Space Academy for those students with a keen interest in Space Education. This program is in its third year and continues to grow.

The newly built Performing Arts facilities continue to showcase the diverse curriculum in Music, Dance and Drama as well as supporting the growth of these subjects.

The College also supports student interest and skills through co-curricular activities and clubs. These include robotics, coding, year7 and 8 camps, sports, Ice Factor as well a wide range of zoned sports including badminton, basketball and tennis.

Governing Council report

2023 was a busy year for the Governing Council. We have had many valuable discussions and had the opportunity to contribute and make decisions that have led to improved outcomes for our students.

It's pleasing to see students in the new uniform items including polo tops and jackets, as chosen by the whole student body and the Governing council at the end of 2022.

The Governing Council spent many meetings discussing the public walkway and fence which has now been erected at the back of the school as the solution to an election promise to residents by Nadia Clancy MP to provide access to move between the northeast to the south of the site. This included meeting with Nadia Clancy MP, along with staff from the Department for Education, to come to a solution which met the needs of both out students and the local residents.

After discussing the introduction of the Mobile Phone Policy in 2022, which allowed students to use their phones during break times but not during class time, the Mobile Phone Policy was again discussed and updated in 2023. The Department for Education's mandate that students were not to use mobile phones at all whilst at school in 2023 meant the newly introduced policy required updating, and additional procedures were put in place. The Phone Pouches, which were ruled out in 2022, were introduced in 2023, with support from the Governing Council. These have been successful with students complying with locking their phones in the pouches at the beginning of the school day and unlocking them at the end of the day. Other policies were also reviewed and amended over the year, including the grievance policy and the Governing Council Constitution.

Governing council members were pleased to attend the official opening of the Performing Arts and Planetarium outreach in 2023. This was attended by the Minister for Education Blair Boyer and the Deputy Premier Dr Susan Close, along with distinguished guest from the Space and Arts industry sector. Official events took place in the Performing Arts auditorium and included speeches and an unveiling of the plaque. This event provided an opportunity to showcase the amazing facility, along with the artistic talents of the students in music and dance. The event concluded with a successful afternoon tea, catered for by the year 11 food and hospitality students.


The Governing Council were also involved in discussions involving the Site Learning Plan, with a focus on continuing with Literacy and Numeracy in 2023. As part of the Site Learning Plan, 2023 saw the introduction of the Dynamic Indicators of Basic Early Literacy Skills (DIBELS) for years 7 and 8. DIBELS is a set of procedures and measures for assessing and improving students' fluency and accuracy in reading and it has been pleasing to see the improvements students have made.

Keeping the costs of living for our families in mind, the Governing Council voted to keep the school fees for 2024 the same as 2023.

NAPLAN Proficiency




Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.

The College has some long-standing systems to track students' daily attendance which include the SMS system. Home group teachers are also responsible to contact home for unexplained attendance. Weekly calls are also made by the Student Services team for students who are not attending regularly. Home visits continue to be the most effective way to connect Aboriginal families with school and to discuss student attendance.
